Programme Fee

The course fee for the entire programme is S\$6,500 (subject to prevailing GST) per person, before applicable funding. The amount inclusive of 7% GST will be S\$6,955

SPRING Singapore funding

To be eligible for SPRING Singapore's funding support (up to 70%)*, participants have to enrol and complete the entire programme. The fee for the entire programme is S\$2,405 (S\$1,950 + GST of S\$455) per person after 70% funding support from SPRING Singapore.

* SPRING's funding support at up to 70% is extended to SME with at least \$10mil in sales revenue:

- At least 30% local shareholdings (Singaporean & Singapore PR): AND
- Company group annual sales turnover of not more than \$100mil; OR
- Company group employment size of not more than 200 workers

Productivity and Innovation Credit (PIC) Scheme

Your Company/Business will also be eligible to claim for tax benefits (400% tax deduction or 60% cash payout**) under the Productivity and Innovation Credit Scheme enhanced in Budget 2012.
