35th SMA National Medical Convention "Seamless Healthcare with EMRX"

he aim of this annual event is to update medical professionals on an important health topic. This year is no exception. The Organising Committee has chosen to focus on the Electronic Medical Records Exchange (EMRX) that has been launched between the two healthcare clusters in April this year. Titled "Seamless Healthcare in EMRX", the Convention was held on a Sunday afternoon of 25 July 2004 at the Suntec Singapore International Convention and Exhibition Centre.

PRE-EVENT SURVEY

We embarked on a pre-event survey to evaluate doctors' perception and acceptance towards the implementation of a national EMR system. We received an overwhelming response from 363 doctors. The majority agreed that EMRX is useful and has a positive impact on their practices.

KEYNOTE SPEECH

We were honoured to have the presence of our new Director of Medical Services, Professor K Satku, to grace the opening ceremony and deliver the keynote speech. Prof Satku spoke of the need to leverage on IT to facilitate the sharing of critical medical information across the healthcare delivery points. The success of any such system requires the collective effort of all stakeholders, and he felt that the most important of these stakeholders are the doctors.





Prof Satku also discussed the problems that

EMRX brings to surface, in particular, protecting patient privacy and maintaining confidentiality. These issues, however, should not delay the progress and achievements of a great worth. He ended the speech by reminding doctors that EMRX is merely a tool, and urged them not to forget to touch and talk to patients.

Associate Professor Goh, a family physician with a strong savvy for IT, talked about how to go beyond the EMRX and make it useful for doctors and patients. He presented the concept of a Continuing Care Record (CCR), which is a document that will contain a core set of health information of a patient and can easily be transferred to the EMR of his or her doctors. CCR will then become a record that the patient holds, and this encourages the patient to be responsible for his or her own health. Prof Goh urged all stakeholders to think about a nationwide joint venture to make it affordable and updated.

CONCERNS ABOUT CONSENT

Ms Kuah, who represented the Law Society of Singapore, sent out a strong message that sharing of records between institutions can potentially be in breach of medical confidentiality and therefore requires consent. Can we dispense with this requirement? Ms Kuah replied that the Central Provident Fund Board has recently tightened the requirements for hospitals accessing patient's Medisave accounts, which is an example of making the rules on access stricter, rather than more lax, when electronic information becomes theoretically more "available". Ms Kuah gave



practical tips on how to obtain consent from patients, and while these steps can admittedly pose some inconvenience to doctors when using EMRX, however, with time and greater familiarity on the part of the public, any teething problems can be minimised in future.
