2. CONSTITUTIONAL AMENDMENTS

As the quorum of at least 50 Members was met, the meeting proceeded to consider and vote on the proposed amendments to the SMA Constitution. The following is only a summary. The detailed report on the consideration and voting of the proposed constitutional amendments will be reported in the minutes of the 45th Annual General Meeting, which will be circulated to Members within a month. Constitution amendments which have been passed will be sent to the Registry of Societies for approval.

i. PASSED

The following proposals to amend the Constitution were passed by the House:

* Life Membership

Article III (ii)(b)

To increase the requirement for continuous Membership from 10 to 20 years, on payment of a sum equivalent to 10 years' annual subscription at Ordinary rate.

* Suspension of Membership

Article V (v)

Ordinary Members and their accompanying Spouse Members who are temporarily absent from Singapore for an extended period of one year or more, can request for suspension of Membership and waiver of subscription.

* Termination of Membership

Article VII (4) *new

Any Member who has passed away will cease to be a Member.

* Amendments to Constitution and Rules

Article XII (1)

Amendments to the Constitution and Rules can be made at the Annual General Meeting (AGM) or an Extraordinary General Meeting (EGM). The proposed amendments shall be made in writing to the Honorary Secretary at least 30 days before the AGM or EGM, and circulated to all Members not less than 14 days before the AGM or EGM.

* Permit Amendment of SMA Constitution at Extraordinary General Meetings

Article XI (2)

An EGM can be convened by the Council at any time for considering amendment to the Constitution or Rules of the Association and / or any special reason. Upon receipt of a requisition in writing from any 50 Ordinary Members stating the purpose for which they require an EGM to be convened, the Council shall convene it within 30 days. The notice shall be sent to all Members not less than 14 days before the EGM.

* Quorum

Article XI (3)

The quorum at all General Meetings (AGM or EGM) shall be 50 Members. In the event of a lack of quorum after the stated time of commencement, the President shall postpone the meeting for 30 minutes, after which the

Members present (whatever their numbers) shall constitute a quorum for the meeting. Such a postponed AGM or EGM shall not be permitted to amend the Constitution or Rules.

ii. DEFEATED

The following proposals to amend the Constitution were defeated:

* Life Membership

Article III (ii)(c)

To be granted automatically to Ordinary Members who have been in continuous Membership for 40 years without any further payment of subscriptions.

(Note: It was suggested that this was redundant bearing in mind an existing Article that offers Life Membership following retirement, upon meeting certain conditions.)

* Honorary Membership

Article III (iii)

May be conferred posthumously.

* Annual Subscriptions

Article V (ii)

To increase annual subscription rates.

* Management of the Association

Article VIII 3(b)

Procedure to promote universal voting of SMA Council Members through postal ballots.

Article VIII (5)

Additional criterion for presidential candidate.

3. SMA HONORARY MEMBERSHIP

Members present unanimously supported the election of **Dr Oon Chiew Seng** and **Prof Aline Wong** to SMA Honorary Membership, in accordance with SMA Constitution, Article IV, Section (iv).

4. APPOINTMENT OF SMA TRUSTEES TO SMA PTE LTD

In accordance with SMA Constitution, Article XIII, Section 2, Members present unanimously ratified the decision of the 45th SMA Council to appoint the following as SMA Trust Fund Trustees for the 5-year term 2005 to 2010:

The SMA Council wishes to express its appreciation to **Dr Robert Loh Choon Kiat** for his service as a SMA Trustee for the period 2000 to 2005. Dr Loh will step down as SMA Trustee after the SMA Pte Ltd's Annual General Meeting in June 2005. Prof Low's appointment will take effect thereafter.

5. APPOINTMENT OF PROFESSIONAL AUDITORS

Members present unanimously agreed to re-appoint M/s Lo Hock Ling & Company as the Professional Auditors for the ensuing year as proposed by the 45th SMA Council. ■
