2. MOM RELEASES 5TH EDITION OF GATIOD

The Ministry of Manpower has published the Fifth Edition of A Guide to the Assessment of Traumatic Injuries and Occupational Diseases for Workmen's Compensation (GATIOD), which has taken effect from 1 January 2007.

The two key changes are updates to existing chapters on renal function; respiratory function and upper and lower limb function to align with newer developments in the assessment of such disorders and the addition of three new chapters on Gastro Digestive Tract, Central Nervous System and Visual Function.

The Fifth Edition of the GATIOD applies to all initial medical assessments done on or after 1 January 2007 irrespective of the date of accident. For objection cases requiring reassessment by the Workmen's Compensation Medical Board, where the initial assessment was based on the last edition, the re-assessment should continue to be based on the last edition for consistency. The Fifth Edition of GATIOD may be referred to in cases where there was no guidance given in the last edition.

The Workmen's Compensation Medical Report forms have also been revised and took effect from 1 January 2007.
