SINGAPORE MEDICAL ASSOCIATION UNCONFIRMED MINUTES OF THE 56TH ANNUAL GENERAL MEETING (AGM)

Held on 17 April 2016 (Sunday) at 2 pm at the Alumni Auditorium, Level 2, 2 College Road, Alumni Medical Centre, Singapore 169850

At 2 pm, there were 13 members and were insufficient for quorum required under Article XI, Section (3)(i) of the SMA Constitution. The President, Dr Wong Tien Hua, adjourned the meeting for thirty minutes in accordance to Article XI, Section (3)(ii). At 2.30 pm, with 18 members signed in, President, Dr Wong Tien Hua called the meeting to order.

At the request of Dr Wong, all who were present rose and observed a minute of silence in memory of 10 members of the Association who passed away since the last AGM.

1 OPENING ADDRESS

- 1.1 President, Dr Wong thanked members present for taking time out to attend the AGM.
- 1.2 In his address to members at the meeting, Dr Wong thanked
- President Tony Tan, for gracing the SMA Annual Dinner 2015, and accepting the SMA Honorary membership;
- Dr Ng Chee Kwan, for chairing and organising the SMA Medical Convention 2015;
- Prof Tommy Koh, for taking up the 2015 edition of the SMA Lecture;
- all council members for their volunteer service to SMA;
- A/Prof Toh Han Chong, for his contributions to SMA, including the Editor of SMA News. A/Prof Toh is stepping down from the SMA Council this year;
- Dr Tan Yia Swam, Editor of SMA News, and the whole SMA News team;
- Prof Poh Kian Keong, Editor of Singapore Medical Journal;
- Dr Lee Pheng Soon, for assisting in matters relating to medical indemnity;
- A/Prof Thirumoorthy, for his contributions to SMA, including as the Executive Director of the SMA Centre for Medical Ethics and Professionalism (SMA CMEP). A/Prof Thiru stepped down as the Executive Director of SMA CMEP at the end of March 2016;
- A/Prof Gerald Chua, the current Executive Director of SMA CMEP for helming a very important work of the SMA:
- the SMA secretariat, for running the daily activities in SMA
- 1.3 Dr Wong highlighted SMA's new slogan, For Doctors, For Patients, which serves to remind all that SMA's focus is not just to serve members, but towards society as a whole, and for our patients. SMA's aim is to protect and enhance the doctor-patient relationship.

2 GROUND RULES

2.1 Honorary Secretary, Dr Lee Hsien Chieh, highlighted the Ground Rules and sought members' cooperation to speak at the microphone and to identify themselves by name for the recording of the proceedings.

3 CONFIRMATION OF MINUTES OF 55TH ANNUAL GENERAL MEETING

3.1 The minutes were adopted as proposed by Dr Wong Chiang Yin and seconded by Dr Toh Choon Lai. There were no matters arising from the 55th AGM minutes.

4 REVIEW OF ANNUAL REPORT OF THE 56TH SMA COUNCIL 2015/2016

4.1 Dr Lee referred members to the SMA 56th Annual Report 2015/2016. He also reminded attendees of the upcoming SMA Annual Dinner on 14 May 2016 at Raffles Town Club

4.2 The SMA 56th Annual Report 2015/2016 was adopted as proposed by Dr Wong Chiang Yin and seconded by Adj. Prof Tan Sze Wee.

5 AUDITED STATEMENTS OF ACCOUNTS FOR YEAR ENDED 31 DECEMBER 2015

- 5.1 Dr Tammy Chan, Honorary Treasurer, presented the accounts for SMA Group.
- 5.2 Dr Chan highlighted a surplus of \$294K for 2015. Compared to 2014, SMA's surplus dipped by 31% or (\$133K), mainly due to a lower fair value gain in investment and increased expenditure towards membership.
- 5.3 The main bulk of income came from services rendered to indemnity providers. The main bulk of expenses were for staff costs. SMA has embarked on initiatives to improve staff productivity, specifically via usage of technology. Examples include online learning tools, online registration for courses and events, self-service membership portal, and online payment portal.
- 5.4 Although membership subscription contributes 22% of total income to SMA, expenditure on membership is about 28% of total expenditure, before we factor in publication expenses.
- 5.5 Adj. Prof Tan Sze Wee, Chairperson of SMA Pte Ltd (SMAPL), presented the accounts for SMAPL.
- 5.6 He highlighted that SMAPL's main role was to invest SMA's surplus to generate a better return as compared to bank deposits. The total value of the investments is about \$4.2 million, with roughly 2.5% returns yearly. UBS is SMAPL's appointed agent for managing investments.
- 5.7 Due to expected market movements in 2016, SMAPL is undertaking a rebalancing of it's portfolio, towards a growth focus. There are also plans to consider a capital purchase for a building, either for usage as a secretariat office, or for better returns. A property committee has been set up to look into these plans.
- 5.8 Dr Bertha Woon proposed and Dr Toh Choon Lai seconded to adopt the audited SMA financial statements for the year ended 31 December 2015.
- 5.9 Dr Toh Choon Lai proposed and Dr Wong Tien Hua seconded to adopt the audited SMAPL financial statements for the year ended 31 December 2015.

6 SMA CHARITY FUND (SMACF)

- 6.1 Prof Wong Tien Yin, Chairperson of the SMA Charity Fund (SMACF), provided a brief on SMACF's objectives, past projects and activities, and upcoming plans.
- 6.2 Prof Wong thanked the SMACF Board of Directors who has contributed time and energy, and new ideas for the charity.
- 6.3 He highlighted the unique nature of SMACF's approach, to help cover living expenses for needy medical students. He hoped that these beneficiaries will become SMA members and contribute back to SMA and society. The key indicators for SMACF were highlighted.
- 6.4 Prof Wong thanked the many donors and SMA members who make regular contributions to SMACF.
- 6.5 Upcoming projects include a survey on the living expenses of medical students and fund-raising activities.
- 6.6 Dr Lee YV proposed and Dr Toh Choon Lai seconded to adopt the audited SMACF financial statements for the year ended 31 December 2015.

7 ELECTION OF SMA HONORARY MEMBERS

7.1 In accordance with Article IV, Section (iv) of the SMA Constitution, the House considered the proposal of the 56th SMA Council to elect Professor Balasubramaniam Ponnampalam, Adj. Associate Professor Lim Lean Huat, and Professor Ong Yong Yau, as SMA Honorary Members.

7.2 The members present unanimously affirmed Council's proposal to elect Prof Bala, Adj. A/Prof Lim, and Prof Ong to SMA Honorary Membership. The conferment of Honorary Membership will be held during the SMA Annual Dinner.

8 ELECTION OF 57TH SMA COUNCIL

8.1 The names of the 10 Council Members who would be serving their second year on the Council were announced.

10 APPOINTMENT OF PROFESSIONAL AUDITORS

10.2 Members present approved by majority via show of hands, the appointment of Kreston David Yeung PAC as Professional Auditors for the ensuing year.

11 ANY OTHER BUSINESS

11.1 Dr Wong Tien Hua highlighted the SMA Council has been concerned by feedback regarding the business practices of some managed care organisations (MCOs). Some MCOs are charging doctors a 10-15% admin fee. This amount is of concern, especially when levied on a substantial operation fee, as it may be construed as a form of fee-splitting. SMA has written a letter to the Singapore Medical Council to seek guidance on this matter.

There being no other matters, Dr Wong Tien Hua declared the AGM closed at 3.05 pm.
