PRESIDENTS' MESSAGE

The Singapore Medical Association (SMA) and the medical profession weathered yet another busy and eventful year. In the last 12 months, SMA has stayed firmly on its course to rally doctors in Singapore towards higher standards of medical professionalism.

The core mission of the medical profession has always been to make a difference in the lives and health of our patients. At the macro level, this involves putting in place policies and systems that promote good delivery of care. At the individual patient level, it is represented by excellent diagnostic and therapeutic skills, and the ability to make sound clinical iudgement in the face of complexity and uncertainty. Equally important is the emphasis of medicine as a moral community, guided by a professional ethos that encompasses virtues of altruism, respect, fidelity, justice

The core mission of SMA is fully aligned with the above ideals of the medical profession. In addition to promoting patients' wellbeing and interests, SMA also believes that doctors are most effective and trusted by their patients when equipped with high professional morale and morals. Therefore, SMA is fully committed to ensuring that the practice environment for doctors in Singapore is reasonable and supportive, thereby freeing doctors from unnecessary encumbrances, and enabling them to devote their professional time and energy to the ethical provision of cure and care. As the professional body representing a majority of doctors in Singapore, SMA has been promoting its core mission via several key strategies.

One of SMA's key missions has been to enhance the level of trust between the profession and society, and that between doctors and patients. In Singapore today, patients rarely doubt the clinical competency of doctors, but quite a few lack confidence in the intent and conduct of doctors. SMA, through the positions that we take in relevant issues and the provision of educational activities that equip our doctors in ethics, professionalism and health law, has been relentlessly advocating and nurturing the trustworthiness of our doctors and the profession. Our efforts to promote doctor-patient communication have also contributed to more effective engagement between doctors and patients.



In addition, the SMA leadership has continued to advocate the role of SMA as the 'Voice of the Profession', by providing independent and constructive feedback to policy makers, regulatory agencies and other professions. SMA closely monitors the impact of healthcare policies on professional practice, and where necessary, we also collate useful feedback from our members and negotiate patiently for a fair and reasonable regulatory climate that will both uphold good clinical practice and cultivate good doctor-patient relationships. An example of this is our painstaking efforts in providing feedback, together with the Academy of Medicine, Singapore (AMS) and the College for Physicians, Singapore (CFPS) to help improve the draft for Singapore Medical Council's Ethical Code and Professional Standards.

SMA has stepped up its efforts to engage and collaborate with fellow professional bodies, medical alumni and relevant external partners, convinced that it will yield more coordinated and effective results in our projects and endeavours. At the international front, SMA has also stepped forward to assume leadership roles in regional federations of medical associations, learning actively from our engagement with leaders from other countries. As in previous years, SMA has made engaging junior doctors and medical students from within and without Singapore a priority. All these efforts serve to ensure that SMA continues to be a progressive professional body with a well-balanced suite of programmes for internal and external engagement.

The medical profession continues to be well regarded as a respectable profession, and locally at least, medicine remains the profession of choice for many idealistic and intelligent young men and women. However, it is important for the profession and its members to be sensitised and to remain in touch with some of the social realities faced by the rest of society. In this regard, the SMA Charity Fund is now into its 3rd year, having achieved its Institution of a Public Character (IPC) status since 27 December 2013. The SMA Charity Fund is set up to provide financial assistance for a variety of social concerns both within the profession and in the general community. These include helping exceptional medical students from needy families, promoting a culture of volunteerism among doctors and medical students, supporting community initiatives related to preventive medicine and providing regular education forum to the public. We believe that these efforts will complement well the ad hoc pro bono practice already undertaken by many of our doctors whenever they encounter needy patients in their practice.

I would like to take this opportunity to express my sincere thanks to all who have stepped forward to volunteer their valuable time and energy in the various committees in SMA. The achievement by SMA is truly the sum of all your efforts. I would especially like to put on record my sincere thanks to A/Prof Toh Han Chong for his ten years spent on transforming the image of SMA News as its Editor. Under his astute leadership. SMA News has become today a must-read for both doctors and non-doctors in the healthcare industry, and even journalists. I would also like to express my gratitude to the following former Presidents of SMA for their services as trustees: Dr Yong Nen Khiong (SMA Pte Ltd), Dr Khoo Chong Yew (SMA Trust Fund) and Dr Low Lip Pin (SMA Trust Fund). We are truly grateful for their many years of service as they step down from their responsibilities as trustees.

Through the many challenges faced, SMA and its leadership have emerged wiser and more resilient. It is regrettable that there are still a handful of doctors who fail to see the relevance of membership to their own practice. I am confident that many of the benefits and positive changes that we achieve through our patient engagement and late-night discussions extend beyond our members to help each and every registered practitioner in Singapore. But representation has both qualitative and quantitative relevance. It is therefore my earnest wish that the growth in SMA, which indirectly mirrors the development of the profession itself, will be in both depth and numbers. For those who have been firmly behind us, on behalf of the Council, I would like to express our sincere thanks. Let us soldier on together to further enhance the relevance and contribution of the profession to Singapore.

HONORARY TREASURERS' REPORT

We are pleased to report a surplus of \$427,252 for the SMA Group, which will be set aside for future capital expenditure. Our combined accumulated fund, which amounts to \$6.6 million, is expected to sustain the work of the SMA Group even in times of unexpected decrease in income.

In 2014, we remained committed to continuously advocate for an improved healthcare system in Singapore, for both doctors and patients. This focus on advocacy is resource-intensive, and thus, a large proportion of our resources was devoted to staff and related costs, to support the increased volume of work and to sustain the quality of our work. This reflects the direction that the Association is headed - to become a dynamic organisation helmed and propelled by volunteers and members, and ably supported by salaried staff. The next significant expense comprised expenditure related to resources, courses and activities targeted at our membership. These include our publications, course materials, seminars, and social and sports-related events, which are either complimentary or made available at a heavily subsidised rate to our members.

Our revenue for the year was generated from various sources. Membership subscription supplemented approximately one-quarter of our total annual expenditure. Other revenue sources that enabled us to be financially viable included income generated from our work as the representative office of indemnity providers,

advertisement income from our partners and commercial advertisers, and rebate income from the UOB-SMA Platinum Visa Card.

In 2014, our investment committee, chaired by the Executive Director of Singapore Medical Association Pte Ltd (SMAPL), continued to realign part of our investments in view of the current investment environment. Our annualised investment return improved from 2.29% to 2.71% since its inception in July 2008. We continued to invest mainly in bonds and to aim for a reasonable return of investment in a low-risk portfolio. The investment committee is also constantly on the look-out for possible investment opportunities in funds or other alternative investments, with the view of achieving potentially higher returns within acceptable risk.














REPRESENTATION AND ADVOCACY

OUR APPROACH

As the national medical association, SMA is committed to engaging in dialogue with various stakeholders on issues related to patient care and medical practice, by highlighting concerns received via feedback from members, and proposing alternative policies, where applicable. At SMA, we adopt a wide spectrum of approaches, ranging from quiet diplomacy to public position statements, to help advocate the rights of patients and doctors.

2014 HIGHLIGHTS

- National Telemedicine Guidelines SMA provided feedback to the Ministry of Health (MOH) on aspects pertaining to the practicality and the possible implications of telemedicine.
- Workplace Safety and Health Act SMA suggested edits to the risk assessment checklist to help medical clinics comply with requirements under the Act. The risk assessment checklist was used at SMA's Workplace Safety and Health seminar held in November 2014.
- Guide to organising a primary care clinic during an influenza pandemic SMA provided feedback on possible improvements to the existing guide.
- Personal Data Protection Act –
 Advisory Guidelines for the
 Healthcare Sector
 SMA met with MOH to discuss data
 protection scenarios faced by the
 healthcare sector. We subsequently
 submitted feedback during the
 public consultation period, and
 organised a seminar for members in
 August and November 2014.

Medical records

In light of the submission of queries to SMA by members unsure of how long medical records should be kept, SMA wrote to MOH to enquire about the ideal retention period of medical records. MOH's reply was published in SMA News' April 2014 issue. New MOH guidelines were subsequently published in January 2015.

Medical students

SMA organised several dialogue sessions with students from the three medical schools, highlighting current medical issues and receiving feedback on issues related to medical education.

Collegiality

SMA had regular meetings with representatives from the Academy of Medicine, Singapore (AMS) and the College of Family Physicians Singapore (CFPS). These dialogues assist greatly in the exchange of information and discussion of issues that affect the medical profession

Clinic licensing period

SMA provided feedback to MOH on the practicality of publishing the licensing period of medical clinics. We recommended the inclusion of information on why a particular clinic has a short licence in any public database. This will help patients understand that a short clinic licence does not automatically mean that the clinic has poor compliance or disciplinary records. The updated clinic directory was launched by MOH in August 2014.

Regulation of liposuction SMA provided feedback on the proposed changes to the regulation of liposuction. The finalised licensing conditions were published by MOH in October 2014.

National Ethics Capability Committee

SMA was invited to be a member of the new committee, which is currently planning a national framework of ethics education for doctors, dentists, nurses and pharmacists in Singapore.

Medical Protection Society (MPS)

Draft 2014 SMC Ethical Code and

Professional Standards SMA alerted members to the consultation exercise, and asked for feedback from members. We requested for a time extension, to allow members more time to review the long document. SMA subsequently drafted a position statement and asked for feedback from members, so as to better reflect the views of the medical profession. In all, 535 votes were received, of which 526 voted in support of our position statement. Feedback, including anonymised comments by individual SMA members, were submitted to Singapore Medical Council (SMC). SMA's feedback to SMC was shared with our members in full via e-mail on December 3, 2014. SMA also facilitated a joint AMS-CFPS-SMA letter to SMC, highlighting the concerns of the three professional bodies.

Member assistance

SMA provided advice and assistance to a member with employment issues, and the issue was subsequently resolved.

2014 CHALLENGES

With 7,058 members from diverse backgrounds, we realise that issues faced by the medical profession will invariably see opposing views and opinions. Thus, every position and opinion put forth by SMA has to take this into consideration. It is not always easy to stay true to our mission of advocating a better healthcare system for both doctors and patients, but the enthusiastic feedback and opinions received from our members encourage us in our endeavour.

MOVING FORWARD

The medical profession will continue to face challenges, both globally and locally, such as with possible pandemics and our ageing population. SMA will continue to represent and be an advocate for patients and doctors, and push for a more inclusive and collaborative healthcare landscape in Singapore.

I hope SMA will be recognised by both the society and medical profession as the moral compass and heartbeat of a caring medical landscape that is able to fairly protect the interests of all.

MEDIA EXPOSURE

MEDIA EXPOSURE

In 2014, SMA took official positions on important issues related to both doctors and patients, sparking active discourse and creating awareness of issues pertinent to our current medical landscape. These areas of concern include medical fee guidelines, healthcare manpower in the palliative care sector, and SMC's disciplinary processes. Aided by SMA publications' growing influence on the local healthcare landscape, we aim to continue bringing greater awareness to issues that impact both doctors and patients for the betterment of local healthcare.

7 March – 28 March 2014 Leisure noise-induced hearing loss Lianhe Wanbao, The Straits Times, The New Paper and Shin Min Daily News

The February 2014 issue of *SMJ* featured a research paper titled "The music listening preferences and habits of youths in Singapore and its relation to leisure noise-induced hearing loss". On 7 March, *Lianhe Wanbao* cited in its editorial that "one in six young persons in Singapore is at risk of developing leisure noise-induced hearing loss from music delivered via earphones." *The Straits Times*, *The New Paper* and *Shin Min Daily News* reported findings from this study in their 28 March newspaper editions.

7 July 2014
Healthcare manpower in the palliative care sector

It was reported that MOH estimates that manpower capacity in the palliative care sector will have to double from the current 150 to 300 by 2020, so as to meet the expected end-of-life care needs

of more than 10,000 Singaporeans. However, SMA 1st Vice President Dr Wong Tien Hua pointed out that it is difficult to make palliative care training compulsory for all doctors. He opined that the best way forward is to find out whether doctors have greater interest in treating elderly patients and chronic conditions, or are more accustomed to treating acute conditions.

25 July 2014 Singapore Medical Council's disciplinary process TODAY


SMC announced that they broadly agreed with the recommendations made by the Review Committee (for Disciplinary Processes) to further enhance the local disciplinary framework for doctors. Dr Wong Tien Hua commented, "Many of the changes reflect the principles of greater transparency, natural justice, and a more efficient system to (reduce) the time required to clear individual complaint cases."


An issue that the Review Committee raised pertained to the current adversarial process; they proposed a shift in the disciplinary process from one that works upon charges levelled against a doctor to one with an inquisitorial framework. SMA welcomed this recommended shift in the disciplinary framework, as these changes would benefit the profession. Dr Wong further highlighted that an inquisitorial system offers the advantage of seeking the truth for all parties, instead of taking sides.

28 July-1 September 2014 Guidelines on Fees AsiaOne, Channel NewsAsia, Lianhe Zaobao, The Straits Times, TODAY and TV News

SMC expressed hopes in July 2014 that laws governing doctors' fee guidelines may be amended to override competition regulations in Singapore. Reports noted that in 2010, the Competition Commission of Singapore ruled against SMA's Guidelines on Fees (GOF) (in force 1987-2007). SMA's GOF was abolished because they were deemed to have breached Section 34 Prohibition of the Competition Act and interfered with free market competition. Some writers felt that the guidelines were relevant as a reference for doctors and patients; in the absence of fee guidelines, some doctors may increase their fees to test the limits of what the market can bear.

On 1 September 2014, various media outlets reported that MOH took the feedback received into account and published data on operation fees at public hospitals on its website, so as to increase transparency and help patients make more informed decisions. Dr Chong Yeh Woei. SMA's ex-President and a current SMA Council Member, opined that should SMA decide to republish the fee guidelines, time would be needed to regather the information, seeing as the Association has not drafted fee guidelines since 2006. SMA has emphasised the need to obtain approval from the authorities before republication of the GOF.

THE HEART OF OUR WORK

OUR APPROACH

Our members are at the heart of what we do. We remain focused on engaging the profession and delivering services that our members value. These include providing resources and opportunities to aid our members in their development as a medical professional and a leader in their respective fields.

2014 HIGHLIGHTS

Broadening our representation

Complimentary SMA student membership was an initiative started in 2012 to engage local medical students as they train to enter the medical profession. This year, we continued to extend this collegiality to our future doctors by conducting a series of talks to share about the vision, mission and work of SMA. We also actively invited the graduating classes of medical students to convert their student membership to ordinary membership in order to enjoy the full benefits of being part of the largest independent professional body for medical doctors in Singapore. In addition, recruitment drives were conducted throughout the year to engage the medical profession at large. We are heartened that 750 new members have joined our ranks this year.

Expanding our online resources

As more doctors take to online platforms to perform their day-to-day transactions, SMA has likewise worked to expand our online resources to members. Our range of online resources includes the SMA Forum and Ethics Consultation, which provide platforms for members to discuss challenges, raise concerns, as well as seek the opinion of their peers and other experts. SMA Jobs Portal and Locum Online provide avenues for members to seek out employment opportunities. Course materials from SMA Centre for Medical Ethics and Professionalism and other professional seminars, as well as *Singapore Medical Journal* CME questionnaires can also be accessed online by our members, thus providing ample opportunities for learning and growth.

Interest groups and membership events

Numerous interest groups, ranging from sporting to lifestyle events, were held during the year. Started by members for members, these interest groups enable members to network and build friendships across ages, specialties and institutions in a relaxed and informal environment. In the course of the year, 25 events attended by approximately 2.500 members and their guests were organised.

We also collaborated with multiple organisations to provide members with tangible and unique benefits. These include the UOB-SMA Platinum Visa Card with perpetual fee waiver; discounted rates for the Medical Emergency Response Programme, insurance schemes, and medical equipment and books; exclusive benefits for luxury car purchases and servicing; and corporate hotel rates, among others.

Feedback and mediation

SMA runs a feedback channel that allows the public to raise concerns regarding their experiences with doctors. This channel, unlike that of the Singapore Medical Council, does not have statutory powers, and the committee overseeing these complaints act as the middle persons to mediate between the parties. This feedback channel seeks to build trust between patients and their doctors, and to resolve miscommunication and other minor disputes through clear communication and discussion, with the help of the committee.

• Updating of membership database Towards the end of 2014, we conducted a membership database updating exercise. This longoverdue update keeps the contact details of our membership current, allowing us to better engage our members and inform them of our advocacy work and upcoming programmes.

2014 CHALLENGES

Explaining the value proposition of the SMA membership continues to be a challenge in our recruitment and retention efforts, as the importance of professional representation to create a better medical practice environment is often overshadowed by the perceived lack of membership benefits.

Furthermore, as pre-emptive discussions and quiet negotiations are generally the preferred methods of problem-solving in the Singapore context, such close-door advocacy efforts embarked by SMA may not be apparent to our membership at large.

MOVING FORWARD

In 2015, we will seek to increase our recruitment and engagement efforts, to expand our current representation of more than 60% of locally trained medical professionals. We hope to further engage the foreign-trained doctors, who currently make up a much smaller proportion of our membership.

In addition, we will double our efforts to communicate to the medical profession about the roles and functions of the SMA, so that all medical practitioners – whether local- or foreign-trained, junior or senior, specialist or non-specialist – can better appreciate the need for strong representation by a well-supported independent professional body.

20 SMA 55TH ANNUAL REPORT

CENTRE FOR MEDICAL ETHICS AND PROFESSIONALISM

OUR APPROACH

The SMA Centre for Medical Ethics and Professionalism (CMEP) was officially launched in June 2000 to promote the art and science of medical ethics and medical care for the betterment of patient care and public health. SMA CMEP aims to provide leadership in the areas of academic training, discussion, resource development and research, so as to support a high standard of medical professionalism.

2014 HIGHLIGHTS

- We collaborated with the Academy of Medicine (AMS), the Law Society of Singapore (LSS) and the State Courts of Singapore (State Courts) to organise the inaugural AMS-LSS-SMA-State Courts Medical Expert Training Seminar. The objective of the seminar was to equip medical practitioners with the legal knowledge and skills required to prepare medical expert reports and give oral expert evidence in proceedings before the Singapore Courts. The trainees were required to complete a written assignment, which was to draft an expert report, and in a role-play situation, give oral evidence as an expert witness before a district judge in actual court rooms.
- We also organised a training workshop, Core Concepts in Medical Professionalism, which was designed to be a train-the-trainers programme that aimed to allow participants to gain a deeper understanding of the important concepts of professionalism.
- Partnering the Medico-Legal Society of Singapore (MLS), we organised a two-day Annual National Medico-Legal Seminar, Understanding Mental Capacity – Concepts and Current Practice. The seminar attracted a wide spectrum of participants from the healthcare and legal fraternities, such as doctors, nurses, lawyers, social workers and hospital administrators, who play distinct and equal roles that contribute to the well-being of the mentally incapacitated.

MOVING FORWARD

With 2015 marking the 15th anniversary of SMA CMEP, we have several projects in the pipeline (e.g. medicolegal talks and publications), which will be announced in stages. One such project is the current collaboration between SMA CMEP and the Office of the Public Guardian to develop an online learning tool and guide for medical practitioners regarding the assessment of mental capacity under the Mental Capacity Act. The objective is to provide medical practitioners with an overall understanding of the Act, as well as the key aspects of mental capacity and its assessment. It also aims to equip medical practitioners with the ability to put together a medical assessment report for the purposes specified in the Act. This project is targeted to launch in mid-2015.

OTHER SMA EVENTS

The 45th National Medical Convention, Active with Allergies, was held on 30 August 2014 at Sheraton Towers Singapore. Featuring three symposiums that comprised 11 talks, the event saw a turnout of more than 340 participants from the public and the medical profession. The Public Symposium aimed to empower its participants to manage their allergies so that they could live as normally as possible. The Lunch and Medical Symposiums, which were attended by doctors, provided a perfect platform for them to share their knowledge, expertise and experience on treating allergies, and to stay abreast of the latest developments in this area.

This year's SMA Lecture was delivered by Prof Tan Chorh Chuan, President of the National University of Singapore, Deputy Chairman of the Agency for Science, Technology and Research (A*STAR), and a renal physician by training. The event, attended by 120 doctors and healthcare professionals. was held on 1 November 2014 at Hilton Singapore. Prof John Wong, Chief Executive of National University Health System, delivered the citation, commending Prof Tan for being a physician extraordinaire, scholar and leader who has made a huge impact on Singapore medicine over the last 20 years. Prof Tan's lecture, entitled Innovating for Future Health, provided an insightful analysis of the challenges confronting Singapore's healthcare, as well as a comprehensive account of innovations embarked on by the Ministry of Health and various hospitals to tackle these challenges. He also shared his views on pertinent steps that should be taken to sustain these efforts.

ACCESS TO KNOWLEDGE

SINGAPORE MEDICAL JOURNAL (SMJ)

OUR APPROACH

A commitment to lifelong learning is part of the professionalism that comes with being a medical doctor. *SMJ* has remained an open-access journal, as we recognise that broad access to research results is an essential component of lifelong learning. We provide access to information-rich literature in the form of scientific research papers, self-learning CME articles, as well as insightful discussions on practice guidelines, medicolegal issues and others. Through waiver of our article submission fee, we also encourage SMA members to share their knowledge and research results with the medical community.

2014 HIGHLIGHTS

- Besides PubMed, Index Corpernicus, Western Pacific Region Index Medicus and ISI Web of Knowledge, SMJ has also been indexed by EBSCO Publishing Inc and accepted to the PubMed Central archive. This is in line with our goal to make our articles more searchable and accessible to researchers around the world.
- We continued to e-publish our accepted articles ahead of print throughout the year. This has substantially improved our publication turnaround time, enabling earlier publication, especially of time-sensitive research papers.
- The Journal's zero tolerance towards plagiarism and duplicate submission, coupled with our investment in technological aids to screen submitted manuscripts, has paid off in 2014, as we saw a drastic decline in such errant cases.
- This year saw a total of 553 manuscript submissions from more than 30 countries, with nearly half the submissions from Singapore. Our acceptance rate remained at around 40%. In all, 206 articles were published, with local papers making up 56% of the published articles.
- The online submission platform for our monthly SMC
 Category 3B CME questionnaires underwent a revamp
 to create a more user-friendly and accessible interface.
 This resulted in a nearly three-fold increase in participation
 from local doctors (3,687 versus 10,743 submissions in
 2013 and 2014, respectively).

2014 CHALLENGES

Attracting high-quality research papers from local and overseas authors remains a continuing challenge. Another challenge is ensuring that submitted articles are processed, peer-reviewed and published in a timely manner.

MOVING FORWARD

We aim to attract more impactful research papers and reviews by expanding the *Journal's* network of local and international authors and editors.

In addition, more effort will be put into increasing the number of e-published ahead of print articles, as well as improving the overall turnaround time from manuscript submission to final decision and print.

Finally, there are also plans to introduce new article categories and to encourage article submissions that focus on research in medical education in the local context.

SMA NEWS

SMA News is a newsletter for doctors, by doctors. We encourage a spirit of free discussion and an exchange of ideas, in the hope that this will spark movement for change and improvement in the management of patients and the practice of medicine in Singapore.

2014 HIGHLIGHTS

2014 saw a renewal of leadership.
After ten years at the helm, A/Prof
Toh Han Chong stepped down as
Editor and was succeeded by
Deputy Editor, Dr Tan Yia Swam.
New blood was infused into the
Editorial Board with the addition of
Dr Leong Choon Kit, Dr Jonathan
Tan and Dr Tina Tan. Long-serving

members, A/Prof Daniel Fung, A/Prof Cuthbert Teo and A/Prof Toh Han Chong were promoted to Editorial Advisors, while Dr Jeremy Lim stepped down after serving for ten years on the board. In January 2015, Dr Tina Tan took on the role of Deputy Editor.

- Five themed issues were published in 2014. The April issue focused on family medicine, while the Doctors in Training issue in July brought attention to challenges faced by trainee doctors and medical students. The September issue centred on allergies in conjunction with the SMA Annual National Medical Convention 2014. Meanwhile, the October issue zoomed in on foreign-trained doctors, an important part of our local healthcare workforce. Finally, the December issue put the spotlight on the heart of SMA our members and volunteers.

 Life in Pixels Photo Competition,
 held from February to October
 2014, was met with encouraging
 response from SMA members.
 A total of 325 entries based on
 a single-word theme were received.
 Winners of all nine themes were
 then entered into a grand prize
 winner contest with online public
 voting.

2014 CHALLENGES

One of the challenges faced was keeping the content in SMA News relevant, interesting and useful to our doctors. Another goal that we constantly strive towards is creating an inclusive publication that encourages participation of doctors from across a range of ages, training backgrounds, specialties and nationalities.

MOVING FORWARD

There are plans to have regular informal networking sessions with writers to create a platform for gathering ideas and feedback, and to establish a group of regular contributors. Plans to introduce new article columns are also in the pipeline.

We also aim to engage newsletter editors of overseas medical associations to build friendship and encourage an exchange of ideas, particularly within the Medical Associations of South East Asian Nations.

Finally, with the success of the inaugural *SMA News* Life in Pixels Photo Competition in 2014, a second run of the photo competition will be held in 2015, with themes centred on SG50, in celebration of the 50th anniversary of Singapore's independence.
