He was pioneer residency director for pathology at SingHealth from 2008 to 2016. He was also Lead for Phase 1 of the MD programme at Duke-NUS Medical School and Assistant Dean for pre-clinical integration until 2016. In 2022, Dr Lai was appointed Chair of the SingHealth Centralised Institutional Board. As director of the SingHealth Tissue Repository, he was involved in the cluster transition into the Human Biomedical Research Act from 2016 to 2019. Outside of the institution, Dr Lai is President of the Medico-Legal Society of Singapore.

A/Prof Anantham Devanand is a Senior Consultant at Singapore General Hospital and Head of SingHealth Duke-NUS Lung Centre. He has trained in lung endoscopy at Beth Israel Deaconess Medical Centre, Harvard Medical School and Thoraxklinik, University of Heidelberg. His clinical interests include lung cancer, respiratory endoscopy, pleural diseases, smoking cessation, and sarcoidosis. He is the vice chair of the National Medical Ethics Committee and serves as Director of the SingHealth Duke-NUS Medical Humanities Institute and Executive Director of Centre of Medical Ethics and Professionalism at the Singapore Medical Association. Malcolm Tan

Consultant and Lawyer, City Law LLC

Malcolm joined the Singapore Legal Service in 1993 and was called to the Singapore Bar in 1994. As a public officer, he served in many roles – including as a Deputy Public Prosecutor and State Counsel, as a District Judge and as a Deputy Registrar of the then Subordinate Courts (now known as the State Courts), and as an Assistant Official Assignee/Public Trustee and Assistant Official Receiver where he dealt with, inter alia, bankruptcies, corporate insolvency matters and trusts.

Whilst in the judiciary, he served mainly as a criminal court judge. He also served as Singapore's State Coroner for several years, in which role he presided over numerous inquiries into iatrogenic deaths, including the post-surgical separation deaths of a pair of conjoined twins who were joined at the head. He was a contributor to the 1st and 2nd editions of the publication "Sentencing Practice in the Subordinate Courts". He is currently a lawyer in private practice. He has delivered many talks locally and internationally on diverse topics running the gamut from the administration of criminal justice, insolvency, and medico-legal issues to risk management and youth protection.

He serves on several committees of the Law Society of Singapore, including the Continuing Professional Development Committee which he chairs.

He is also a Council Member of the Medico-Legal Society of Singapore, in which role he has facilitated and organised numerous medicolegal seminars and workshops.

Clinical A/Prof Gerald Chua is a Senior Consultant who specializes in Internal Medicine and Respiratory Medicine and subspecializes in Intensive Care Medicine. He practises in both the Departments of Medicine and Intensive Care Medicine at Ng Teng Fong General Hospital.

Clinical A/Prof Chua's clinical interest is in the integration of care for COPD (Chronic Obstructive Pulmonary Disease) patients, spanning primary care, specialty care, intensive care and palliative care. His educational interests are in multi-professional education in acute care, crisis resource management, mechanical ventilation and medical professionalism.

He has been appointed Clinical Associate Professor in the Department of Medicine, NUS Medicine. He chairs the Intensive Care Medicine Residency Advisory Committee and the Master of Medicine (Internal Medicine) Committee.

Prof Teo Eng Kiong
CEO, Sengkang General Hospital

Prof Teo graduated with a degree in Medicine from NUS in 1989 and attained his Master of Medicine in Internal Medicine and MRCP(UK) in 1994. He is one of the pioneers of Changi General Hospital and has risen up the ranks to Senior Consultant and Head of Gastroenterology in 2004, Chief of Medicine in 2006, Deputy Chairman of the Medical Board in 2008 and Chairman from 2012-2020. He is currently the Chief Executive Officer at Sengkang General Hospital and the Deputy Group Chairman, Medical Board (Regional Hospital Network) at Singapore Health Services.

Prof Teo was the President of the Gastroenterological Society of Singapore from 2008-2010 and Master of the Academy of Medicine Singapore from 2020-2022. He is currently a member of the Nanyang Polytechnic Health & Social Sciences Advisory Committee. Prof holds Professorship from the Duke-NUS Graduate Medical School as well as NUS Yong Loo Lin School of Medicine and is an Adjunct Professor of the Singapore University of Technology & Design. He is also a member of the Lee Kong Chian School of Medicine Adjunct Teaching Faculty and a Clinical Examiner of the PACES/MRCP, MBBS and Duke-NUS examinations.

Dr Goh Min Liong

Chief Medical Informatics Officer, MOH

Min Liong graduated from the National University of Singapore's School of Medicine in 2003. He initially joined the department of General Surgery at Changi General Hospital where he was initially introduced to the field of Medical Informatics. He participated in multiple initiatives such as electronic nurse charting, computerised physician order entry and inpatient closed looped medication management. He was appointed Chief Medical Informatics Officer in 2018, and assumed the role of Group Chief Medical Informatics Officer for the SingHealth group in 2020. In this role, he oversees the deployment and planning of the groups clinical IT systems.

Min Liong is also the Chief Medical Informatics Officer for the Ministry of Health Singapore since 2020. Emeritus Consultant, Tan Tock Seng Hospital (TTSH)

Assoc Professor Thomas Lew is Emeritus Consultant, Department of Anaesthesiology, Intensive Care and Pain Medicine, Tan Tock Seng Hospital (TTSH).

He was formerly Chairman of the Medical Board at TTSH, NHG Health's Group Chief Data and Strategy Officer and Clinical Director, NHG Centre for MedTec and Innovation. He directed the implementation of NHG's Next Generation Electronic Medical Records (NGEMR) from 2014-22. He served on the Board of IHIS ("Synapse") from 2019-22.

He is a founder member of the Society of Intensive Care Medicine, Singapore, and has served as President of the Singapore Society of Anaesthesiologists and as Secretary-General of the Asian Society of Neuroanaesthesia and Critical Care (ASNACC).

He has published original papers in hospital-based medico-legal disputes resolution, clinical results verification in EMR systems, decision support algorithms in head injury management and EMR analytic systems for hospital antibiotics stewardship programs.



Dr Sumytra Menon

Director, Centre for Biomedical Ethics, National University of Singapore (NUS)

Dr Sumytra Menon is Director of CBME, a legal scholar and bioethics educator whose work bridges academic leadership, research, and national capacity building in healthcare ethics. She is also Co-Director of the Clinical Ethics Network + Research Ethics Support (CENTRES) initiative, where she leads educational efforts in clinical and research ethics to strengthen ethics committee capabilities in Singapore and the Programme Director of Science, Health and Policy-relevant Ethics in Singapore (SHAPES).

A lawyer by training, Dr Menon's research has focused on healthcare decision-making, mental capacity law, and end-of-life issues. She is currently conducting research on the ethics of genetic discrimination and longevity, including a recent national survey exploring public perspectives on genetic testing and discrimination.

Dr Menon's work is policy-oriented, with a focus on translating academic and research insights into practical frameworks that enhance outcomes for patients, families, and healthcare professionals. Her approach is grounded in clinical realities and lived experiences, ensuring that contributions are responsive to the ethical challenges encountered in healthcare practice and research.

Dr Menon serves on a range of national committees and ethics panels, including Clinical Ethics Committees, Institutional Review Boards, and national committees on advance care planning, MediFund and transplant ethics.

Prof Joseph Sung

Dean, Lee Kong Chian School of Medicine, National Technological University

Professor Sung received his medical degree (MBBS) from The University of Hong Kong and conferred PhD in biomedical sciences by the University of Calgary and MD by The Chinese University of Hong Kong (CUHK). He holds fellowships from the Royal Colleges of Physicians of Edinburgh, Glasgow, London, and Australia, the American College of Gastroenterology, the American Gastroenterological Association, the Hong Kong College of Physicians, the Hong Kong Academy of Medicine, Academy of Sciences of Hong Kong (ASHK), Japan Gastroenterological Endoscopy Society and Academy of Medicine, Singapore. He is an Academician of the Chinese Academy of Engineering of the People's Republic of China and Academician of the International Eurasian Academy of Sciences.

He served as the Vice-Chancellor and President of the Chinese University of Hong Kong (2010 – 2017) and the Chair of Worldwide Universities Network (2016 - 2017).

Professor Sung is currently Distinguished University Professor, Senior Vice President (Health & Life Sciences) and Dean, Lee Kong Chian School of Medicine at Nanyang Technological University, Singapore. He is also Emeritus Professor of Medicine at CUHK.

He has published over 1000 full scientific articles in leading medical and scientific journals. He was listed as “Highly Cited Researchers”, released by the Clarivate Analytics, for the years 2018 to 2024. He has edited and authored over 30 books, as well as many chapters in major textbooks including the Oxford Textbook of Medicine (5th Ed.), Sleisenger & Fordtran's Gastrointestinal and Liver Disease (7th & 8th Ed.), and Yamada's Textbook of Gastroenterology (4th Ed).



A/Prof Liu Nan

Associate Professor, Centre for Quantitative Medicine and Programme in Health Services and Systems Research, Duke-NUS Medical School

A/Prof Liu Nan is an Associate Professor at the Centre for Quantitative Medicine (CQM) and Programme in Health Services and Systems Research (HSSR), Duke-NUS Medical School. He leads the Duke-NUS AI Medical Sciences Initiative (DAISI). He is also a faculty member at NUS Institute of Data Science, and a graduate faculty member at Duke University, USA. Clinically, Dr Liu is affiliated with SingHealth.

A/Prof Liu is actively working on AI, machine learning, and data science with their applications in various clinical domains. He is also interested in technology translation and commercialization. He co-founded TIIM Healthcare Pte Ltd and serves as its Scientific Advisor. His research has been funded by the National Medical Research Council (NMRC), National Research Foundation (NRF), National Health Innovation Centre (NHIC), Ministry of Education (MOE), AI Singapore, Duke-NUS Medical School, and SingHealth Foundation, as well as industrial partners such as Continental AG.

A/Prof Liu has served as an Editor for more than 10 prestigious peer-reviewed journals, including npj Digital Medicine, PLOS Medicine, BMC Medicine, and IEEE Journal of Biomedical and Health Informatics. Additionally, he is a regular reviewer for many international journals such as The Lancet, JAMA and Nature Medicine. He also serves on the Program Committees of a number of premium AI and data science conferences such as AAAI, NeurIPS, and AMIA.

Prof Ngiam Kee Yuen

Head of Division, Department of Biomedical Informatics, NUS

Professor Ngiam Kee Yuan leads the AI office at NUHS and the immediate past Group Chief Technology Officer at NUHS. He is the winner of the Singapore Computing Society Tech Leader of the Year Award 2025. In his role at NUS, he is a clinician scientist with 138 publications and 4439 citations, ranging from clinical science to artificial intelligence. He was awarded the NMRC CIDA award in 2021, which resulted in the development of new AI tools, a patent, and high impact publications in Lancet Oncology [IF 36.418] and Nature Digital medicine [IF=15.2]. He is among the world's top 2% of highly cited researchers by Stanford University-Elsevier survey in 2023. His professional interests are innovations in surgery and artificial intelligence (AI) in healthcare. He has founded numerous platforms and programs, including the DISCOVERY AI, ENDEAVOUR AI, the NUHS Holomedicine and MiSSI cloud robotics program. He is a recipient of multiple grants including the Ministry of Health Innovation grant, HOIC Enterprise Singapore grant, and the Infocomm Media Development Authority (IMDA) 5G grant. He holds multiple patents in surgery and AI technology.



Dr Aung Myint Oo

Assistant Chief Clinical Informatics Officer and Senior Consultant, TTSH
